Policy/ programme development and research experience

1. From child health to primary health care (PHC) and community managed initiatives for prevention. Methods development for health impact evaluation.

In Kivu, in the early eighties, I worked in a region where all types of childhood malnutrition and associated conditions were prevalent. My team established prevention activities through a primary health care. We set up together with the local Expanded Programme on Immunization and UNICEF vaccination centres, conducted a health, nutrition and demographic survey along the shores of Kivu Lake in Bulenga peninsula, set up local health committees representing around 30000 citizens, managed community pharmacies and reinforced bean cultures to improve protein intake (see publications 1-3 and 31).

From 1985 onwards, I worked as staff of the London School of Hygiene and Tropical Medicine in research and teaching. I continued leading health, nutrition and demographic surveys (see report 22 in publication list) and worked on child health (Sri Lanka, Burkina Faso and Brazil e.g. publications 40, 41, 73), low birth weight prevention (Sri Lanka and Burkina Faso, publication 71) and Mother to Child Transmission of HIV (see e.g. publications 4,5,8,14,16, 18-21). I designed, conducted, analysed and published with a large team a health impact evaluation of the impact of improved water supply and sanitation facilities (Sri Lanka). We generalized the methods for large-scale case-control studies of common childhood conditions for health impact evaluation of structural interventions (publications 4, 10, 14, 21 23-27, 29, 33). I also worked on better understanding the risk factors for Acute Respiratory Infections and low birth weight in Burkina Faso and Brazil (public. 28).

2. HIV, Sexually Transmitted Infections, epidemiological methods for surveillance, intervention development and evaluation; health systems facing vertical programmes.

As a medical practitioner in Kivu in the early eighties, I experienced the first AIDS cases among young adults with rapidly deteriorating conditions, including untreatable Tuberculosis. As of 1985, I became progressively involved in designing and setting up research and public health intervention programmes in the field of HIV and STIs (Burkina Faso, Tanzania). In

1989, I put forward with two colleagues a proposal to explore the potential impact of systematic detection and treatment of sexually transmitted diseases with community-based randomized control trials (CBRCT). The WHO Global Programme on AIDS invited me to present the approach (publication 20).

Soon after, I joined the World Health Organisation for a sabbatical year and was selected to head the team on Surveillance, Evaluation and Forecasting of the WHO Global Programme on AIDS and STDs. This was a time of great innovation at the cutting edge of international public health surveillance, research and policy/ programme development. We initiated the development of estimation methods from surveillance data to track the HIV pandemic in each country. The team developed methods for the evaluation of national and local HIV and STDs prevention and impact alleviation programmes and modelling methods for projections (publications 29, 30, 32, 34, 46 to 116).

Towards the mid-nineties, decades of health systems underfinancing, vertical programmes working in parallel (including EPI) and the combined threats of major killing diseases challenged entire societies, especially in Africa. As Director of Strategic planning for HIV, TB and Malaria, we worked together with countries to integrate programmes within PHC.

3. Social, economic and environmental determinants of health; building resilience through citizens' participation inter-sectoral action and the life-course approach.

Over 15 years, I had seen malnourished children returning to the hospital six months after treatment and rehabilitation because of their living conditions; I contributed to studies of the interactions between low birth weight, childhood diseases and chronic malnutrition, including stunting. During the late eighties and early nineties, conscious of the importance of improving the structural environment, we focused on water and sanitation programmes, better access to health care facilities, but also improving the rights of e.g. sex workers or injecting drug users.

However, a good deal of our research and policy development had focused practically exclusively on individual behaviours or on specific groups, households or individuals, rather than on the factors rooted in local, regional and broader social and economic policies. I therefore undertook to shift the focus of subsequent work. My involvement in trying to contribute stemming the spread of HIV reinforced my conviction that upstream work with communities and national actors was necessary to ensure a better response and recovery from environmental and social hazards. From 2000 onwards, I decided to address the social, economic and environmental determinants of health, ensuring that citizens engage as priority agents of change.

As United Nations Secretary General Representative, Resident/Humanitarian Coordinator in 2009, 2010 and 2011 (UN Ambassadorial and coordinating function), I worked in a region (Chad, Central African Republic, Cameroon, Northern Nigeria) shaken by widespread poverty, severe disparities, socio-political tensions and unstable security environments. We developed programmes to ensure more transparent governance in local institutions, increased access to resources, and additional support for the service providers.

I have continued to be involved in promoting inter-sectoral action to address the social determinants of health and health disparities when I worked in the Central Asia, Eastern and Southern European region, from the WHO Office in Italy.

Teaching experience

In Kivu, DRC, 1983-1984, I was responsible for the training of medical undergraduates (*Faculty of Medicine*, Kinshasa) studying at the Kirotshe hospital and at IRS (research centre). I trained Medical Officers, statisticians, demographic and health survey's managers, laboratory personnel and interviewers.

Between 1988 and 1991, I played a very active role in the London School's teaching programme. In the late 1980s, I taught a 40 hours course on epidemiology from theory to practice, using Professor Paul Fine's experience in the Masters of *Community (now named Public) Health in Developing Countries* with an interactive teaching approach and a lot of practical work. I also developed and taught a full module on the epidemiology of HIV/AIDS for Masters Courses. Evaluation of teaching from students was consistently very positive.

From 1988 to 1990, I taught the demographic impact of HIV/AIDS at the *Centre for Population Studies*, interventions for diarrhoeal diseases and the epidemiology of Mother to Child Transmission of HIV at the *Institute of Child Health*, both in London. In the MSc course in *Health Planning and Financing* (jointly run by the LSHTM and the London School of Economics), I taught epidemiology and cost-effective approaches for the control of childhood illnesses in 1989-1990. In the MSc in *Clinical Tropical Medicine* I taught the epidemiology of acute respiratory infections and lectured on the potential association between low birth weight and infectious diseases to the MSc in *Human Nutrition*, LSHTM in 1989-1990. In 1993, I was faculty of the *Centre for Population Studies*, part of LSHTM, and taught in the Reproductive Health Course.

Throughout these years, the theory and practice of experiential and participatory learning influenced my approach to teaching undergraduates and postgraduate health professionals and social scientists.

Between 1986 and 1990, I was a tutor of students sitting on the MSc *Community Health in Developing Countries* for their final dissertation. From 1988 to 1996, I seconded tutors of PhD students. Following my move to World Health Organization, these PhD students presented their thesis under the supervision of their main tutor in various Universities (UK, France, the Netherlands and University of Burkina Faso).

In 2006 and 2007, the *Public Health Initiative* team that I was heading as WHO Special Representative put online a "Virtual Resource Centre" (VRC), which increased access to competency-based learning materials in public health (case-studies, presentations, scientific articles) and fostered exchange of such materials. The VRC encouraged public health training institutions to use, adapt, translate and share the learning materials. The first set of materials available was developed in collaboration with the Indian Field Epidemiology Training Programme (FETP) and was organized out of a spreadsheet with hyperlinks. A number of competencies were the primary focus, including epidemiological study designs, disease-specific surveillance, health information systems, outbreak investigation and response, scientific communication, programme management and evaluation, and basic human subject protection.

Throughout my professional career, I took many opportunities to interact with researchers, teaching staff and students of various academic institutions e.g. in South Africa, Colombia, Brazil, India, Sri Lanka, Morocco, Japan, France, Germany, UK, USA, West Africa, Belgium and Italy.

Since 2015, I deliver a keynote lecture entitled "Epidemiology in action and inaction" at the London School of Hygiene and Tropical Medicine to close to 100 students of various backgrounds. I opted to deliver the lecture in an interactive way and ratings by students were consistently very good each year. I have pasted below a couple of students' comments from 2016.

- « This lecture was very interesting as well as important. The speaker raised many issues of concern.
